## **INFORMATION SHEET FOR PARENTS**

## **Central themes of the BBT**

Children love and need both parents. It is important for the development of children to be able to maintain relations with both parents. By the way, the child has a legal claim to contact with both parents. For these reasons, regular contact with both father and mother is important for the child. This is also true when the relationship between the parents is difficult or the meeting between the parent with visiting rights and the child requires a secure setting. The child is to be able to experience a relationship to both parents regardless of the conflicts which exist between the parents. Quarrels between the parents should not take place in the child's presence. The well-being of the child takes precedence over the interests of the parents. The BBT offers a temporary setting for the exercise of visiting rights until the parents, with the help of the specialist unit responsible, have developed a long-term solution.

## Responsibility and roll of the support team

- The support team accompanies and looks after parents and adults in planning contact during the visit.
- The support team ensures the well-ordered course of the transfer and accompanied visiting days.
- The support team sees to the well-being and protection of the child.
- The support team maintains neutrality towards both parents.
- The support team makes a regular report. In addition, it is bound to maintain professional confidentiality.

## Information regarding the procedure during visiting days

- The visiting parent organizes the time with his or her child independently. Afternoon refreshments take place with the whole group.
- Leaving the visiting location during visiting times is not allowed.
- At the visiting location there is the possibility of playing in an garden.
- Toys are available at the visiting location. The parents see to it that nothing is damaged or lost. They put the toys away with the child after use.

- Any damages are to be reported to the support team.
- Third-party accident insurance is the responsibility of the participants.
- Children are allowed to bring their own toys and/or handicrafts material.

- Presents, with the exception of Christmas and birthdays, may only be brought along on agreement with the other parent. Their presentation is to be agreed upon with the support team.
- The sum of CHF 20 will be due on visiting day for general expenses and the afternoon snack. Payment must be made in cash and a receipt will be given.
- In the case of unexcused absences, the full amount including the days missed is to be paid.
- The consumption of alcohol and drugs is prohibited.
- Smoking is banned on the premises. If necessary, possibilities for smoking are to be discussed with the support team.
- Using your cell phone is to be kept to a minimum.
- The recording of images or audio is only permitted of yourself or of your own children. Recordings of other participants and the assisting team are strictly forbidden. Publication on social media is only permitted with the consent of the parent having custody.
